

February 10, 2015

The Board of County Commissioners met in regular session Tuesday, February 10, 2015 at 9:00 a.m. Members present: Mockler, Packard, Powell, Passick, and Manning.

Powell moved, seconded by Manning and carried to approve the agenda with the addition of Legislative Update (SB2) discussion.

Minutes of the February 3, 2015 meeting were approved with a motion by Manning, seconded by Packard and carried.

Rod Polley, Highway Superintendent, met with the Board to discuss highway matters. Powell moved, seconded by Packard and carried to authorize the Chairman to sign the 2015 Agreement to Provide for the Striping and Continuing Maintenance of County Roads within Clay County with the SD Dept. of Transportation.

Passick moved, seconded by Manning and carried to set the bid opening for highway materials for 9:15 a.m. March 3, 2015.

At 9:12 a.m., Powell moved, seconded by Packard and carried to adjourn and convene as Ditch Board.

The Board discussed parcels that have been found to be taxed incorrectly. It appears that in the past, certain properties were split, and the taxes were not split accordingly between the parcels. The issue will be discussed with landowners at the annual joint ditch board meeting and corrected as needed.

At 9:30 a.m., Packard moved, seconded by Powell and carried to adjourn and reconvene as Board of County Commissioners.

The Board discussed the potential impact of SB2 on the County's drainage districts. It was agreed that the Board cautiously supports the bill.
