Packard moved, seconded by Manning and carried to approve the agenda with the addition of Executive Session per SDCL 9-34-19 and a luncheon at Austin-Whittemore House at 11:30.

Minutes of the March 7, 2017 meeting and March 7, 2017 informational re-zoning meeting were approved with a motion by Packard, seconded by Powell and carried.

Jessica Huber, South Dakota Dept. of Legislative Audit, met with the Board to present the closing audit report. Powell moved, seconded by Packard and carried to authorize the Chairman to sign the Management Recommendation Letter.

Rod Polley, Highway Superintendent, met with the Board to discuss highway matters. Powell moved, seconded by Packard and carried to accept the low bid of \$1.749/gallon from Brunick Service for #2 dyed diesel. Manning moved, seconded by Packard and carried to accept low bid of \$1.019/gallon from Long's Propane for propane at the Vermillion shop.

Amendments were discussed to the Application for Occupancy on the Right of Way of County Highways with the input of the Highway Superintendent and State's Attorney.

An Application for Occupancy on the Right of Way of County Highways was presented on behalf of the Town of Wakonda for a water main and services on 302 St. in Section 33, Township 95N, Range 53W in Clay County, SD. Powell moved, seconded by Packard and carried to deny the application.

Polley reported that the timeline for lifting the weight limits will depend on the weather over the weekend.

The Board discussed with Polley the potential damages to roads from a large three-phase electrical project that is underway within the county.

Cynthia Aden, Welfare Director, met with the Board to present Welfare Case #C17-03 for a county funeral. Powell moved, seconded by Hammond and carried to approve the application as the case met welfare guidelines.

Cynthia Aden, Zoning Administrator, met with the Board regarding a re-zoning petition for the area near 321 St. and Missouri St. Packard moved, seconded by Hammond to proceed with the re-zoning petition and waive the fee. All voted aye; motion passed.

Layne Stewart, Emergency Management Director, met with the Board. Manning moved, seconded by Packard and carried to authorize the Chairman to sign necessary documents for the county to receive \$11,050 in Point of Dispensing Grant funds.

Stewart briefly discussed security with the Board.

Powell moved, seconded by Packard and carried to authorize travel for Stewart to Beatrice, NE in May 2017 for necessary training.

Stewart informed the Board that he was nominated by a member of the Centers for Disease Control to serve on a national mass casualty board as a county representative of rural America. It was the consensus of the Board to support Stewart in the endeavor.

It was discussed that the matter may fall under the authority of the township.
